Welcome to the 2024 TLC Annual Report. 2024 was a year of significant growth for the organization. In 2023 we ended the year with a \$6,000 budget. Consolidated audited financial statements are available on our website for calendar year 2024.

TLC has launched new programs in addition to our Annual Tribal Leadership Conference. We have started offering certification courses through our partnerships with KOSO Strategies, the National Native American Human Resources Association, and Oklahoma State University. We have also started our Mentorship Program - Building Future Leaders. The first cohort is scheduled to start in the spring of 2025.

The Board of Directors has grown to eight (8) members. We are pleased to welcome the new Directors to the organization. We have also created the Finance Committee which will also serve as our Investment and Audit Committees until such time as they are separated.

We have begun a webinar series. Our first webinar is with REDW "General Financial Statement Review for Leadership". This will be held in February and followed by other webinars we are planning for the future.

The 2025 Tribal Leadership Conference will feature two certifications on Monday prior to the conference. This year's conference will be June 23-26th at the Palms in Las Vegas. We hope you will join us there.




